### Option 1.

Choose 'Company Search' in order to search and order instant online and database reports. Searching and basic details are free of charge; you only pay for the report taken. Scroll and choose a country from the list, then select your search method (where applicable). Your search will be completed and the report will be delivered instantly (in some cases with an automatic express update included).

### Option 2.

Choose 'Fresh Investigation' – by filling in the online form you can specify the speed of the service you require and any other requirements e.g. the currency used or the credit opinion sought.
